Overview

ICS was developed in the 1970s in California as a response to the challenges of managing large wildfires. It has since been adopted nationwide and is required by Homeland Security Presidential Directive-5 (HSPD-5) for all federal, state, and local response agencies.

Key characteristics include:

- **Common Terminology:** Everyone uses the same words and definitions, reducing confusion.
- **Manageable Span of Control:** No single supervisor oversees more than 3 to 7 subordinates (the ideal is 1:5).

- **Modular Organization:** The structure grows or shrinks based on the incident's needs.
- **Integrated Communication:** All communications are coordinated using plain language and clear procedures.
- **Unified Command:** In multi-jurisdictional incidents, a single command structure is formed with representatives from each agency.

2. ICS Management: Command and General Staff

One of the most tested topics in IS-100.C is the difference between the Command Staff and the General Staff. The **Command Staff** includes:

- **Incident Commander:**
The person in charge of the overall incident.
- **Public Information Officer (PIO):**
Handles external communications and media.
- **Safety Officer:**
Monitors safety conditions and has the authority to stop unsafe operations.

Serves as the main point of contact for other agencies.

The **General Staff** comprises the four sections:

- **Operations Section:** Directs all tactical on-scene response activities.
- **Planning Section:** Collects, evaluates, and disseminates information; develops incident action plans.
- **Logistics Section:** Provides resources, facilities, transportation, supplies, and services.
- **Finance/Administration**

Section:

Manages costs, contracts, and compensation.

Answers involve identifying which staff member performs a specific function. For example, who is responsible for monitoring safety? The Safety Officer (Command Staff). Who orders food and supplies? Logistics (General Staff).

3. The Incident Action Plan (IAP)

The IAP is a central component of ICS. It is a document that specifies the objectives and tactics for a specific operational period (usually 12 or 24 hours). The Planning Section is responsible for developing the IAP, but it is approved by

the Incident Commander. The IAP includes:

1. Incident objectives.
2. Organizational structure.
3. Resource assignments.
4. Communications plan.
5. Medical plan.
6. Safety message.

4. Span of Control and Organizational Flexibility

Span of control refers to the number of subordinates a supervisor can effectively manage. In ICS, the recommended

ratio is 1:5 (one supervisor for every 3-7 subordinates). This ensures that communication is clear and that no one is overwhelmed. If an incident becomes too large, the Incident Commander can expand the organization by adding sections, branches, divisions, or task forces. Conversely, if the incident winds down, the structure can be simplified.

5. Facilities and Locations

ICS uses standard facility names to avoid confusion:

- **Incident Command Post (ICP):** The location where the Incident Commander and Command Staff

- operate.
- **Base:** The primary logistical support location.
- **Staging Area:** A temporary location where resources await assignment.
- **Camp:** A location for sleeping, eating, and other support services for personnel.
- **Helibase:** A primary location for helicopter operations.

Questions on the exam may ask you to identify the facility where resources are held before deployment. That is the **Staging Area**.
