Other states may require just a registration or bond. You may also need specialty licenses for electrical, plumbing, or HVAC work if you subcontract those trades. Research your local contractor licensing board, and apply for the appropriate classification. Additionally, you'll need a business license from your city or county, and possibly a seller's permit if you buy and resell materials.

Insurance is non-negotiable. The bare minimum includes:

- **General Liability Insurance:** Covers property damage and bodily injury to third parties. Essential for protecting your business when you are on client sites.
- **Workers' Compensation Insurance:** Required in most states if you have employees. It covers medical costs and lost wages if a worker is injured on the job.
- **Commercial Auto Insurance:** For vehicles used for business purposes.
- **Tools and Equipment Insurance:** Protects your investment in case of theft or damage.

Many general contractors also require subcontractors to have their own insurance. Work with an insurance agent who understands the construction industry to tailor a policy that fits your risks.

Register for Taxes and Get an EIN
